

SoFi Securities (Hong Kong) Limited Privacy Policy

This Privacy Policy ("Policy") describes how SoFi Securities (Hong Kong) Limited ("we", "us" or "our") collects and uses the personally identifiable information ("Personal Information") you may provide on the sofi.hk ("this site"). By using this site, you are agreeing to the terms set out in this Policy.

Collection of Personal Information

When you visit this site our servers automatically record information that your browser sends. This data may include personal information such as your device's IP address, browser type and version, operating system type and version, language preferences or the webpage you were visiting before you came to this site, pages of this site that you visit, the time spent on those pages, information you search for on this site, access times and dates, and other statistics.

Collection of Cookies

We may record your visit to this site for analysing the number of visitors to this site, general usage patterns and your personal usage patterns and improving your experience. We may gather some of this information through the use of "cookies". Cookies are small bits of information that are automatically stored on your web browser in your computer, mobile phone or other device for accessing the internet that can be retrieved by this site. We will be able to access the information stored on the cookies and record how you use this site.

Use of Personal Information and Cookies

We may use your personal information and cookies for various purposes described below:

- Conduct surveys, market research, and data analytics
- Maintain, improve, research, and measure the effectiveness of our sites, activities, tools, and services
- Market our products and services, optimize such marketing to be more relevant to you, and measure and analyze the effectiveness of our marketing and promotions

They use technologies such as cookies, spotlight monitoring (this manages tagging which is used for example, to track which advertisement users clicked on to take them to a site) and web beacons (these are used to monitor the behaviour of the user, for example whether they scroll down a page) to collect information for this research. They use the information collected through such technologies (i) to find out more about users of this site, including user demographics and behaviour and usage patterns, (ii) for more accurate reporting and (iii) to improve the effectiveness of our marketing. They aggregate the information collected and then share it with us.

As part of the information that we share with them, we may share your advertising identifier and "installation event" (which means the data in relation to when you first install or use this site).

Your Rights and Choices

<u>Cookies</u>

Most browsers are initially set to accept cookies. If you accept cookies during your use of this site, you will be acknowledging that your information is being collected, stored, accessed and used as outlined above.
