- 1. To ensure SIs are successfully completed on specific settlement date, please provide instructions by 4pm of previous business day. 為了確保交收指示在指定的交收日期完成,請在上一個工作天4pm前提供指示。
- For physical scrip deposit, 對於股票現貨存入。
- We will process your request once we receive your physical scrips. The name on the physical scrip must be the same as the name of the account holder. —旦收到您的股票現貨,我們將處理您的申請。現貨的名稱必須為帳戶持有人的名稱相同。
- If the share certificates are registered in the name of a nominee, then you need to provide proof of beneficial ownership. 如果現貨是在代名人的名義登記,那麼您需要提供實益擁有權證明。
- Sale order of physical stock will only be accepted after 14 working days when the physical stock has been deposited into CCASS and good title of the stock has been obtained.

對於理貨提取

- We will contact you when the scrip is ready to be collected. You may self-collect the scrip or authorize a 3rd party to collect with original copy of the signed authorization letter.
- 我們將通知您前來提取股票現貨。您可自行提取或書面授權第三方並帶同已簽署的授權委託書的正本前來提取。
- The letter must include 3rd party name, ID number, stock code, stock name and number of shares with the following clause: "I/We hereby agree to keep you fully indemnifi ed from and against any loss, claims, demands, cost of proceedings caused by or arising from this authorization."

- Scrip must be collected within 14 business days after it is ready. SoFi Securities (Hong Kong) Limited will re-deposit the scrip into CCASS if it is not collected after 14 business days. Handling fee will be charged again when you make another withdrawal instruction for the re-deposited stock(s). 現貨必需在14個工作天內提取。否則,公司將重新存中央結算系統。當您再次重新提取已存入的股票,我們將再次收取手續費。
